## **WORK ORDER**

**Subject: - POTABLE WATER SUPPLY THROUGH TANKERS FROM NIPA HYDRANT TO DISTRICT EAST, KARACHI.**

Subsequent to the issuance of letter of Acceptance vide letter No. KW&SB/ Ic.O (HS/TO)/LOA/Auction-2023/03 dated: 20/04/2023 and the execution / signing of contract agreement for the above-mentioned work amounting to **Rs.384,013,872/- (Rupees Three Hundred Eighty Four Million Thirteen Thousand Eight Hundred Seventy Two Only)**, you are directed to start the work forthwith and complete the same within the stipulated time of **730 Days** strictly as per specifications and conditions of the contract.

You are further directed to contact concerned Engineer In charge Hydrant through the undersigned to obtain necessary direction/s to start and operate the Hydrant, as per specified criteria written in the bidding documents as well as follows:

- i. Professional / Competent representative/s should remain present all the time at Hydrant site till completion of work. Also intimate / inform the name/s of in charge and representative along with the rest of staff with their C.Vs. duly attested.
- ii. All necessary safety measures / arrangements should be ensured at Hydrant Site **Near Sindh Board of Technical Education Office, Block-6, Gulshan-e-Iqbal, Karachi** e.g. diversion board, Red lights arrangement, Barriers, protection of civil structure in order to avoid any mishap and damage to underground water supply network and machineries. You will be held responsible for any fault / disorder / damage and will be responsible to repair all installed machineries and underground (invisible) service/s, during the currency of the contract period.
- iii. All other terms and conditions will remain same as defined in the contract.
- iv. Work Program as per contract shall be submitted within 06 (six) days of the receipt of this letter.
- v. A proper display board with pre-approved text by KW&SB, should be installed and maintained by the contract through the contractual period and up to warranty period.
